



## **Instructions and Annexure(s) For Ranking of PE and Sports Institutions**

### **Introduction:**

We at Confederation for Sports and Recreation Industry (CSRI) are starting a first of its kind ranking system for physical education and sports institutions both at national and state level. Though a ranking system has been in place for many years in Medicine, Engineering and Humanities, there has been no ranking system in place for Sports and Physical Education. The final ranking system will be divided across not just at a national and regional level but also for individual categories like Faculty, Placements, Teachers, Vocational Courses etc.

### **Eligible Institutes:**

- i) Physical Education Universities
- ii) Physical Education Colleges
- iii) Sports Universities
- iv) Sports Colleges
- v) University Departments and /or Faculties
- vi) Sports Management Institutes
- vii) Institutes offering Sports Management and Sports Vocational courses as a separate subject or qualification/degree/certificate/diploma

**Note:** This is for institutes which provides Sports and/or Physical Education courses for career opportunity

### **Objectives of the CSRI ranking system**

- a) Creating an organised market for Sports and Physical Education system when it comes to higher education in India
- b) Identifying the Best Sports and Physical Education Institute in India across various parameters:
  - i) Quality of Infrastructure
  - ii) Research and Professional Engagements in the Institute
  - iii) Quality of Teaching, Learning and Resources
  - iv) Outreach and Inclusivity
  - v) Overall Perception of the Institute
- c) Helping students and their families make an informed choice about choosing the right educational institution



- d) Offering benchmarks to help reach the right target audience. Students can choose a university/institution on the basis of different parameters or dependent of region they wish to go.
- e) Creating a competitive system amongst universities to improve the status of facilities and courses offered

### Institutes Benefits through Ranking System:

#### a) Quality Assessment:

- **Benchmarking:** CSRI Ranking provides a way to compare institutes against each other, allowing stakeholders to identify the strengths and weaknesses of different institutions.
- **Quality Assurance:** A ranking system can serve as a quality assurance mechanism, encouraging institutes to maintain high standards in sports, physical education, research, and other relevant areas.

#### b) Promotes Competition:

- **Motivation for Improvement:** Knowing their position in a ranking motivates institutes to strive for excellence and continuous improvement in various aspects, including academic performance, faculty quality, and infrastructure.

#### c) Student Decision-Making:

- **Informed Choices:** Prospective students and their parents can use rankings as a tool to make informed decisions about where to pursue education. It helps them choose institutions that align with their academic and career goals.

#### d) Research Output Recognition:

- **Research Performance:** Ranking systems often consider research output and impact, which can motivate institutes to focus on producing high-quality research. This recognition can also attract talented researchers and foster a culture of innovation.

#### e) Alumni and Industry Perception:

- **Employability:** Institutes with higher rankings are often perceived as producing graduates with better skills and knowledge. This perception can enhance the employability of graduates from these institutions.

#### f) International Visibility:

- **Global Recognition:** Higher-ranked institutes gain international visibility, attracting students and faculty from around the world. This can lead to increased collaboration, cultural diversity, and a broader global impact.

#### g) Funding Opportunities:

- **Attracting Investments:** Top-ranked institutes are more likely to attract funding from government bodies, private organizations, and philanthropic individuals. This financial support can be crucial for infrastructure development, research projects, and scholarships.



**h) Accreditation and Accountability:**

- Accountability Measures: Rankings can act as external accountability measures, pushing institutes to meet certain standards to maintain or improve their positions.

**i) Strategic Planning:**

- Strategic Decision-Making: Institute administrators can use ranking data for strategic planning. This includes identifying areas for improvement, setting goals, and allocating resources more effectively.

**j) Networking and Collaboration:**

- Partnerships: Higher-ranked institutes are often more attractive partners for collaborations with other institutions, industry, and research organizations. This facilitates knowledge exchange and joint initiatives.

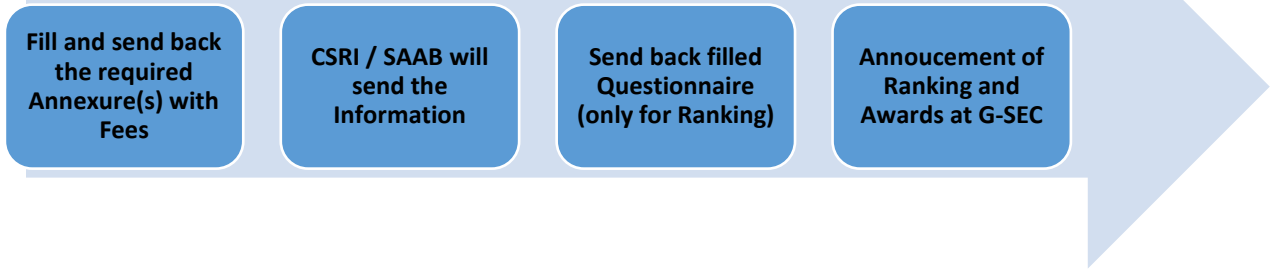

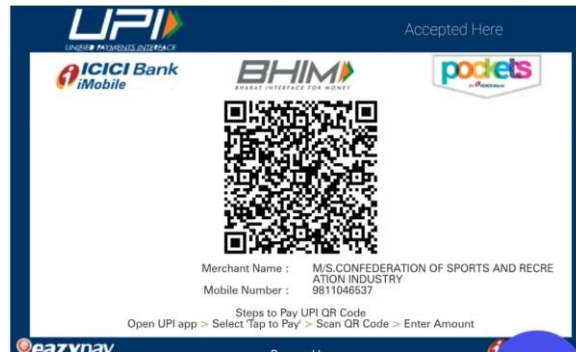
